I,, the purchaser of the greyhound detailed above and recorded in the Greyhound Adoption Program (GAP) register, hereby agree to accept the animal with any and all faults, blemishes, or imperfections, and exonerate the management of the Program, and the Queensland Racing Integrity Commission (QRIC) from any responsibility in respect to the said greyhound. Furthermore, I understand and will comply with the following terms & conditions of adoption:

- I will change all microchip details to my name and address within 14 days of adoption.
- The Program will reclaim any healthy adopted greyhound for a refund of the adoption fee, less a \$75 administrative fee, until 28 days after adoption.
- Should the greyhound become ill from a previously undetected pre-existing or chronic condition within seven days of this adoption, the Program will take all reasonable steps to treat or replace the animal. I understand that any other treatments, during the life of the greyhound, are my financial responsibility.



- I am fully responsible for the greyhound, including for any actions, damage or injury caused by the greyhound.
- I release the Greyhound Adoption Program and the Queensland Racing Integrity Commission from any liability arising from my care of this greyhound and/or its behaviour or actions.
- I will ensure that when the greyhound is taken into a public place, it will always be appropriately leashed and controlled by a capable person, and in accordance with Local Laws.
- I acknowledge the recommendation from the Program staff that the greyhound should not be allowed off leash in any public area including off-leash parks, or in any private area that is not adequately fenced.
- I understand that this greyhound has been assessed by GAP as suitable for adoption and is not required to wear a muzzle, and that it must wear it's issued Green Collar when in public areas.
- I acknowledge that the GAP's assessment of this greyhound is an evaluation of the dog's behaviour at certain points in time and under particular circumstances, and that future behaviour under different circumstances may vary.
- I understand that children and small pets should always be supervised by an adult when in the company the greyhound (or any other dog).
- I will ensure that the greyhound is registered with my local council and any other authority as required by laws or regulations and I will abide by all Local Laws.
- I understand that to the best of GAP's knowledge, this greyhound is not suffering from any ill-health or disease and is behaviourally sound, however the Greyhound Adoption Program and the Queensland Racing Integrity Commission offer no warranties.

GREYHOUND ADOPTION PROGRAM ASSESSMENT DISCLAIMER NOTIFICATION

Your greyhound has successfully passed the Greyhound Adoption Program's National Temperament Test to become an approved 'Green Collar GAP Greyhound' in Queensland. **This in no way guarantees your dog's future behaviour in all situations.**

GAP greyhounds can be in public without a muzzle in most local government areas, provided that the approved Green GAP collar is worn. *Please confirm this with your local Council as Local government regulations can vary significantly between council areas, and some will require all greyhounds to be muzzled regardless of their GAP status. It is the responsibility of every dog owner to understand and comply with all local laws and regulations. As with all dogs, a GAP greyhound that is in a public place must be on leash, held by and under the effective control of a competent person.*

We strongly recommend that you do not allow your greyhound off-leash in any public area. This is because the GAP assessment is conducted on-leash and the dog's behaviour in an off-leash situation cannot be guaranteed. If you do decide to allow your greyhound to be off-leash in designated council off-leash areas, the greyhound must be wearing its approved collar and be under the effective control of a competent person. We strongly recommend that this is only ever done in a securely enclosed or fenced area and with your greyhound wearing an appropriate greyhound muzzle.

When in a designated council off-leash area the competent person is responsible for controlling the greyhound's behaviour which includes ensuring the greyhound is not in breach of any of the provisions of the *Animal Management (Cats and Dogs) Act 2008* or any Council local laws. A greyhound that has been granted a muzzling exemption under



Part 2, 197(3) of the *Animal Management (Cats and Dogs) Act 2008* must continue to comply with all other relevant legislative requirements. Even within a designated council off-leash area, it is an offence for a dog to rush at, attack, bite, harass or chase any person or animal, or cause fear, whether or not any injury is caused.
